# 9.0 Animals and Animal Product Import & Exports

Trade in live animals, meat and their products both at a local and international level form the basis for livestock/animal farming for business purposes. Trade, the demand and supply of animals and their products provides food, gainful employment as well as making positive contributions to the economy of the country at a micro and macro-economic level; including the earning of foreign exchange (currency). Swaziland is actively involved in both the importation and exportation of animals and their products. Some of the consignments that leave Swaziland are however imported items that transit through the country, invariably destined to Mozambique.

#### 9.1 Livestock and Animal Product Trade

Tables 47 and 48 show the volumes of meat and other edible animal products imported into Swaziland, categorised by product and country of origin. In all, a total of 17,638.34 tons of meat and other animal products were imported into the country in the year 2012, valued at E 244,898,559.40 (as reported by SRA and shown in Table **50**). The total amounts of animal products exported from Swaziland during the year 2012 were as follows; Meat 1,038.16 tons, Animal Feeds 310 tons, Cattle hides 218,768 pieces and 2,400 dozens of eggs. The total value of all meat and animal products exported were valued at E 19,691,022.36. On the other hand table x shows the amount meat and other animal products exported by Swaziland within the year. It should be noted, however that the numbers of cattle hide pieces accounted for in table 40 are specifically those exported from the export abattoir (SG1) and exclude the 16,274 pieces exported by other exporters.

Tables 51 and 53 show the classes and numbers of live animals imported into and exported from Swaziland in the year 2012, respectively (including wildlife). Tables 52 and 54 on the other hand show the monetary values of the live animals both imported and exported from Swaziland within the year 2012. The total value of live animals Imported into Swaziland was E 18,912,235.56 and those exported from the country were valued at E 14,246,089.90 (values obtained from SRA). The animals and their values are placed in separate tables because the Ministry of Agriculture and the Swaziland Revenue Authority (SRA) have different systems of recording and categorising animals and their products, a point clearly expressed by the product codes shown in the aforementioned tables. SRA adheres to the Southern African Customs Union (SACU) system of coding and classifying products, while the Department of Veterinary & Livestock Services of the Ministry of Agriculture has its own system of classifying animals and animal products.
